## IMPORTANT NOTICE

Delinquent tax bills will be transferred to the Clark County Clerk's Office as of the close of business on April 15, 2025. After April 15<sup>th</sup>, contact the County Clerk's Office for payment. In addition to the penalties and fees that are applied by the Sheriff's Office, payments made in the County Clerk's Office are subject to a 20% County Attorney's fee, a 10% County Clerk's fee and interest at 1% per month. Any delinquent bills are also subject to being sold to a third party.

### **Payment Options -**

- 1) By Mail: Mail check or money order to Clark County Sheriff, 17 Cleveland Avenue, Winchester KY 40391. We honor USPS postmark (not private meters) on all payments received via US mail. If you want a paid receipt returned to you, please enclose a self-addressed stamped envelope.
- 2) <u>Dropbox</u>: Place personal check, certified check, or money order in the drop box off West Broadway in front of the Sheriff's Office. Identify the bill(s) you are paying by the bill number, map number, and/or address.
- 3) Online: Visit our website <a href="www.clark.kysheriff.org">www.clark.kysheriff.org</a> and click on **Property Taxes** or go directly to the <a href="Clark County Online Portal">Clark County Online Portal</a> to pay by debit, credit, or Google Pay. Merchant service fees apply.
- 4) <u>In Person</u>: Personal check, certified check, money order, and cash are acceptable forms of payment. Debit and credit cards are accepted, merchant service fees apply. The Sheriff's office is in the basement of the Governor James Clark Judicial Building. The office will be open from 8:00 am until 4:00 pm Monday through Friday.
- 5) <u>NEW</u> <u>Pay at Traditional Bank</u>: Personal check, certified check, or money order are acceptable forms of payment at the downtown Winchester location only, 30 West Broadway, during their business hours. Payment must be for the **exact amount due** and **accompanied by the tax bill**. Cash payments will not be accepted at this location.
